4. Methods of use of data

5. Scope of data circulation

The data may also be processed by third-party companies that carry out activities on behalf of the Data Controller, in their capacity as external data processors (by way of example and not limited to: credit institutions, professional studios, suppliers / consultants who manage and/or participate the management and/or maintenance of the electroic and/or telematic tools used by us, insurance company for the provision of insurance services, for the time strictly necessary for the optimal execution of this service). Your personal data will be made accessible only to those who have an effective need for it in relation to the exercise of their job or hierarchical position. 7. Dissemination of data

The data will not be disclosed to indeterminate subjects.

8. Transfer of data abroad

The data will not be transferred outside the European Union. In any case, it is understood that the Data Controller, if necessary, will have the right to move the location of the servers to non-EU countries. In this case, the Data Controller ensures from now on that the transfer of non-EU data will take place in compliance with the articles 44 ss. of the

Regulation and the applicable legal provisions stipulating, if necessary, agreements that guarantee an adequate level of protection.

9. Data Controller and Data Protection Officer

10. Exercise of rights

As an interested party in the processing of data, we inform you that you have the possibility to exercise the rights provided for by the Regulation, and precisely:

a) the right, pursuant to art. 15, to obtain confirmation as to whether or not personal data concerning you are being processed and, in this case, to obtain access to personal data and the following information: i) the purposes of the processing ii) the categories of personal data in question;

iii) the recipients or categories of recipients to whom the personal data have been or will be communicated, in particular if they are third countries or international organisations; iv) when possible, the envisaged retention period for personal data or, if this is not possible, the criteria used to determine this period; v) the existence of the right of the interested party to ask the Data Controller to rectify or cancel personal data or, if this is not possible, the criteria used to determine this period; v) the existence of the right of the interested party to ask the Data Controller to rectify or cancel personal data or limit the processing of personal data concerning him or to oppose their treatment; vi) the right to lodge a complaint with a supervisory authority, pursuant to articles 77 ff. of the Regulation; viii if the data are not collected from the interested party, all the information available on their origin; viii) the existence of an automated decision-making process, including the profiling referred to in Article 22, paragraphs 1 and 4 of the Regulation, and, at least in such cases, significant information on the logic used, as well as the importance and expected consequences of such processing for the data subject; ix) the right to be informed of the existence of adequate guarantees pursuant to article 46 of the Regulation relating to the transfer, if the personal data are transferred to a third country or to an international organisation;
